1. Indenture, December 25, 1832. Mahlon Hall paid \$100 to Hiram and Susannah Daniel in exchange for 80 acres of land in Macon County, Ill.
2. Indenture, March 2, 1834. Mahlon Hall paid \$375 to Elisha and Mary Butler in exchange for 80 acres of land in Macon County, Ill.
3. Indenture, July 5, 1836. Henry H. Hall paid \$100 to Darius Hall and Mary Hall in exchange for 80 acres of land in Macon County, Ill.

4. Land Grant Certificate, No. 2944, March 20, 1837. Entitles Henry H. Hall and Darius Hall of Macon County, Ill., to 158 and 68/100 acres of land in the NE quarter of Sec. 5, Twp. 19 North, Range 1 E of the 3rd P.M. Land office, Danville, Ill. Signed by A. Van Buren for President Martin Van Buren.
5. Land Grant Certificate, No. 3832, April 1, 1837. Entitles Henry Harrison Hall to 80 acres of land in the East half of the SW quarter of Sec. 3, Twp. 19 North, Range 1 E of the 3rd P.M. Land office, Danville, Ill. Signed by A. Van Buren for President Martin Van Buren.
6. Indenture, Sept. 20, 1839. Ivy Norflet and John Norflet of Wayne County, Ky., paid \$600 to Mahlon Hall in exchange for land in DeWitt County, Ill.

7. Deed of Sale, April 18, 1840 [fragment]. James and Elizabeth Farris sold land to Mahlon Hall.
8. Indenture, April 18, 1840. Mahlon Hall paid \$1,300 to James and Elizabeth Farris in exchange for 300 acres of land in DeWitt County, Ill.
9. Receipt, May 2, 1840. James Farris received \$400 from Mahlon Hall in partial payment for land in DeWitt County, Ill.
10. Indenture, Dec. 26, 1845. Giles and Martha Wells of Van Buren County, Iowa, received \$1,200 from Mahlon Hall in exchange for 420 acres of land in DeWitt County, Ill.
11. Receipt, Dec. 2, 1865. J. R. Hall paid his dues to Masonic Lodge, No. 84, Clinton, Ill.

12. Letter, Nov. 4, 1869. James Lisenby, DeWitt County Clerk, certifies that Jonathan R. Hall was duly elected DeWitt County Judge.
13. Certificate, Nov. 23, 1869, stating that Jonathan R. Hall was elected DeWitt County Judge, and signed by Gov. John M. Palmer.
14. Cattle sale contract, Feb. 14, 1874. J. R. Hall and R. V. Owens of Clinton, DeWitt County, Ill., will pay John Warner five cents per pound for 41 head of cattle.
