Correspondence, 1835-1841

- 1. Ezra Miller (Brooklyn, New York) to Horace Miller (Mount Morris, New York), November 29, 1835.
- 2. Ezra Miller (Brooklyn, New York) to Horace Miller (Mount Morris, New York), February 29, 1836.
- 3. Ezra Miller (Brooklyn, New York) to Horace Miller (Kishwaukee, Winnebago County, Illinois), discussing ditch construction and house and land prices, April 6, 1838 [likely 1839 since Horace did not leave for Illinois until that year],
- 4. Ezra Miller (Brooklyn, New York) to Horace Miller (Mount Morris, New York), discusses visits to railroads throughout the country and possibility of Horace and Ezra looking at lands in the West Michigan, Ohio, Illinois but not expecting a paradise, May 28, 1838.
- 5. Ezra Miller (Norwich, Connecticut) to Horace Miller (Mount Morris, New York), ask why one would go west when one was successful, especially at the cost of losing the conveniences of an older settlement, July 8, 1838.
- 6. Ezra Miller (Brooklyn, New York) to Horace Miller (Mount Morris, New York), August 8, 1838.
- 7. Ezra Miller (Brooklyn, New York) to Horace Miller (Mount Morris, New York), discusses the hiring of Irishmen for ditch digging and the supplying of seeds, groceries, and implements for a farm, November 29, 1838.
- 8. Ezra Miller (Brooklyn, New York) to Horace Miller (Kishwaukee, Winnebago County, Illinois), discusses and diagrams the fencing of the property in Illinois, March 21, 1839.
- 9. Jonathan Miller, another brother, (Mount Morris, New York) to Horace Miller (Kishwaukee, Winnebago County, Illinois), with added note from Eliza Miller, Horace's daughter, June 6, 1839.
- Ezra Miller (Brooklyn, New York) to Horace Miller (Kishwaukee, Winnebago County, Illinois), discusses description and disposition of property in order to clear title, February 5, 1840.
- 11. Ezra Miller (Brooklyn, New York) to Horace Miller (Kishwaukee, Winnebago County, Illinois), discusses planting and lists seeds to be used, April 20, 1840.
- 12. Ezra Miller (Brooklyn, New York) to Horace Miller (Rockford, Illinois), discusses crop markets, September 24, 1840.
