Diaries and Notebooks of Richard Owen

This series consists of two bound volumes. A third volume was held by Alice Owen Neal in 1950 but was not microfilmed. The third volume was a notebook containing outlines for scientific lectures delivered at Georgetown, Kentucky, and other miscellaneous scientific notes of Richard Owen dated December 7, 1849, through May 31, 1850.
