All are addressed to Harry E. Pratt, unless otherwise noted.

- Angle, Paul M., October 7, 1949, regarding the lack of openings for "historical work." Atlantic Monthly (Charles W. Morton, Jr.) to Pratt and Ernest E. East, January 17, 1942, rejecting their proposal to "put together some interesting details from Mrs. Lincoln's affairs."
- Barker, H. E. (Lincoln Fellowship of Southern California) to M. L. Houser, March 24, 1937 (typed copy on Abraham Lincoln Association stationery), on books owned by Lincoln.
- Bailey, Theodore L., Harriman, New York, January 14, 1951, regarding "an exotic cane which belonged to Dr Charles A. Leale."
- Barondess, Benjamin, New York, April 30, 1954, on the wording of a telegram from Edwin M. Stanton to Lincoln, two days before the Gettysburg Address: was it "A. Carnegie will call for you at 12" (Louis A. Warren, Lincoln Lore, #1023, November 15, 1948) or "A carriage will call for you at 12" (Collected Works, 7:16)? According to Barondess, Three Lincoln Masterpieces (1954), 36, the latter reading is correct.
- Bartley, Joseph L., Shawneetown, Illinois, January 25, 1940, on documentation of the Dorman litigation.
- Barton, Bruce, New York, April 19, 1938, declining an invitation.
- Barton, Robert S., Foxboro, Massachusetts: September 2, 1940, on postmasters in New Salem, with Pratt's note on verso; July 23, July 31, August 16, 1950, on Zarel C. Spears and Robert S. Barton's *Berry and Lincoln* (1947).
- Benadum, Clarence E., Muncie, Indiana, April 24, 1951, sending Pratt a copy of his novel, *Bates House* (1951).
- Bishop, Jim, New York, March 15, 1955, and Bantam Books, February 14, 1956, regarding Bishop's *The Day Lincoln Was Shot* (1955).
- Bollinger, James W., Davenport, Iowa, to Paul M. Angle, April 18, 1927, mentioning the Browning diary.
- Bonzi, Marion Dolores, November 6, 1949, on David Donald, *Lincoln's Herndon* (1949); December 10, 1949, on Benjamin P. Thomas, *Portrait for Posterity: Lincoln and His Biographers* (1947); December 11, 1949, on editing the "Writings" [The Collected Works of Abraham Lincoln], and January 28, 1950, on *Luckett v. Ruckel* (1839) [typescript of a plea apparently not in The Law Practice of Abraham Lincoln]. Each letter also touches on other matters. Also Harry Pratt, Muskegon, Michigan, to Marion Bonzi, with a carbon of a letter from Pratt to his Devore in-laws, September 14, 1950.
- "Books Across the Sea" Society of America (May Lamberton Becker), New York, to Hjordes Lind Pratt, July 17, 1946, enclosing nine items by or about the organization.
- Broadcast Music, Inc. (Russell Sanjek), May 7, 1953, regarding a review of Lloyd Lewis's *Captain Sam Grant* (1950).
- Brown, Mary Edwards (1866-1958), Dunellen, New Jersey, undated, regarding purchase of certain furniture: "say what you will give for it." She was the Lincoln Home custodian, 1918-24 [Wayne C. Temple, *By Square & Compass: Sage of the Lincoln Home* (2002)].

- Bryan, G. S. [George Sands], Pelham, New York, November 29, 1941; April 11, 1942, regarding his book, *The Great American Myth* (1940), including a typescript of part of J. G. Randall's review of the book in the *American Historical Review*, 46:4 (July 1941), 941-42, and criticizing T. Harry Williams, *Lincoln and the Radicals* (1941) and Margaret Leech, *Reveille in Washington* (1941).
- Bullard, F. Lauriston, Boston, Milrose Highlands, Massachusetts, May 9, 1941; June 16, 1943; September 14, November 15, December 3, December 13, 1949; March 14, September 6, 1950, on current Lincoln matters, including notes on Milton H. Shutes, *Lincoln and California* (1943); prospects for Lincoln Memorial University, and a satisfactory position for Pratt himself. Also a typed copy of letter to Marion Bonzi, December 31, 1949, applauding her "selection for the [Collected] Works job."
- Butt, Harry S. (Clerk, Circuit Court, Decatur, Illinois), May 21, 1940, regarding a Lincoln case in 1839.
- Chenery, William Dodd, inscription on a flyleaf of one volume in a set of J. Fenimore Cooper's works: "To my esteemed friend, Harry E. Pratt." Chenery also wrote: "John William Chenery, and his father, William Dodd Chenery, I, were the last hosts, in the Chenery House, in Springfield, of Abraham Lincoln." The flyleaf of other volumes of the set read "Jno. W. Chenery / Springfield / Ills / July 1st '58."
- Corneau, Octavia, Boston, Massachusetts, to Alice Bunn, undated, enclosing An Address by Abraham Lincoln on the Death of Mr. Benjamin Ferguson, Delivered February 8, 1842 (Monaghan 1778; Collected Works, 1:268-69) and an envelope for this item in the hand of John W. Bunn.
- Cowan, Emeline, Pontiac, Illinois, April 26, 1944, and Pratt to Paul M. Angle, May 22, 1944, regarding her father, Augustus M. Cowan.
- Dathpalia[?], Y. P. (National Archives, New Delhi), December 21, 19[29?], season's greetings.
- Davis, David (grandson of Judge Davis), Bloomington, Illinois, March 7, 1929, offering to make the judge's papers available to Pratt.
- Davis, Granville, Little Rock, Arkansas, November 1, 1949, thanking Pratt for assistance with his Ph.D. dissertation, "Factional Differences in the Democratic Party in Illinois, 1854-1858" (Illinois, 1936).
- Dennett, Tyler (President, Williams College), June 2, 1937, on being unable to "inveigle" the college library into becoming a library member of the Abraham Lincoln Association.
- Dick, Jane W. (Mrs. Edison Dick), Lake Forest, Illinois, March 19, 1953, regarding her book, *Whistle-Stopping with Adlai* (1952).
- Donald, David, February 28, 1951, and January 30, 1953, on obtaining pamphlets by and about Senator Charles Sumner, and on reviewing *The Collected Works of Abraham Lincoln*.
- East, Ernest E., Peoria, Illinois, May 29, 1939, regarding certain legal cases in Peoria, 1850-53.
- Edwards Brothers (lithographers and publishers, Ann Arbor, Mich.), to Paul M. Angle and to Pratt, May 12, 23, September 9, 1938; August 3, 1939, proposing a change in the format of the Lincoln Day by Day series, including a page of Lincoln: 1847-1853 (1936) to illustrate this change; Pratt's notes on the costs; information on the company's lithoprinting.

- Felsenthal, Morton, undated, mock certificate of the Confederate States of America, making Pratt an "Honorary Colonel in the Confederate Air Force."
- Fifer, Joseph W., Bloomington, Illinois, August 5, 1931, praising Pratt's thesis on David Davis.
- Gates, Arnold F., Cleveland, Ohio, May 7, 1941, sending a copy of his second *Amberglow* (on Joshua Speed).
- Gernon, B. B., Columbus, Ohio, April 30, 1943.
- Halbert, Sherrill, Porterville, Calif., September 9, 1941, acknowledging a copy of Paul M. Angle's booklet, *The Marine Bank* (1931) and praising the new Abraham Lincoln Quarterly.
- Hertz, Emanuel, August 4, 1929, to Paul M. Angle, faulting Angle for not crediting Hertz for items included in the manuscript of *New Letters and Papers of Lincoln* (1930) that Hertz first "brought to the surface." Also Angle's note on Hertz's *Abraham Lincoln: A New Portrait* (1931), Vol. 2, listing both the number of published items that Hertz represented as new and the pages containing "Lines cribbed from Angle."
- Hix, John, on "Strange As It Seems" stationery, May 25, 1938, thanking Pratt for furnishing data for a story.
- Houser, M. L. (Martin Luther), Peoria, Illinois, typescript of letter from Esther C. Cushman (Charles W. McLellan Collection of Lincolniana, Brown University), March 30, 1937, commenting in detail on Houser's list of books thought to have been read by Lincoln; postcards, Houser to Pratt, November 23, 1938, June 29, 1940, in part regarding *Elliott's Journal and Debates of the Federal Constitution* (1836).
- Illinois State Library (Helene H. Rogers), undated, regarding two copies of Carl Sandburg's *Always the Young Strangers* (1952) that he autographed for Pratt and his daughter.
- Indiana University Press, November 18, 1954, wanting the mailing list of the *Journal of the Illinois State Historical Society* in order to promote Lewis Atherton's *Main Street on the Middle Border* (1954).
- Jacobs, Warren (Secretary, Railway and Locomotive Historical Society, Inc.), November 8, 1940, verifying the wording of the tablet to mark the site of the Hudson River Railroad station in New York at which Lincoln passed on February 19, 1861, and his funeral train passed on April 25, 1865.
- James, Marquis, Pleasantville, New York, November 18, 1937, returning "the [Andrew] Jackson photostats."
- Jones, Zarel, Honolulu, Hawaii, September 22, 1941, enclosing a card regarding her uncle, Thomas Dow Jones. The card, issued by C. B. Galbreath, Ohio State Librarian, refers in particular to Jones's Lincoln and Soldier's Memorial in the Ohio Capitol.
- Judson, Clara Ingram, from Pratt, July 9, 1950, regarding her book, *Abraham Lincoln: Friend of the People* (1950); Wilcox & Follett (publisher) to Pratt, March 22, 1951. Proofs of the book, annotated by both Harry and Marion Pratt, are in Section 4.
- Kentucky Historical Society (Bayless E. Hardin), August 3, 7, 1953, providing data on tax books of Hardin County, Kentucky, in 1799-1802, 1810-1811, and Pratt's note of thanks for the information.
- Kilby, Frank L., Bloomington, Illinois, February 18, 1935 (forwarded to Pratt by Louis A. Warren's secretary), recounting what he was told by "Beyers" [Abraham Byers] regarding Byers' photograph of Lincoln in Beardstown, Illinois, May 7, 1858. His

- account approximates that in Lloyd Ostendorf, *Lincoln's Photographs: A Complete Album* (1998), 14 (O-5).
- King, Willard, to Benjamin P. Thomas, November 30, 1953, on an 1852 Lincoln letter regarding a legal fee, and on Abraham Brokaw's story about Stephen A. Douglas withholding a sum due Brokaw, "a disbarable offense today."
- Knopf, Alfred A. (Harold Stauss), January 31, 1941, acknowledging receipt of Pratt's January 25 letter and notes on corrections to make in Henry Villard's *Lincoln on the Eve of '61*, ed. Harold G. and Oswald Garrison Villard (1941).
- Lackey, George A., Lawrenceville, Illinois, November 8, 1939, regarding a receipt signed by Lincoln relating to the estate of Daniel L. Gold.
- Lewis, Lloyd, August 4, 1938, stating that he does not recognize Grant or anyone else in a picture sent to him by Pratt; Kathryn Lewis, April 6, 1954, on the disposition of Lloyd Lewis's research notes.
- Lincoln Fellowship of Pennsylvania (Coleman, J. Walter), undated, mimeographed report on a meeting in Gettysburg on November 19.
- Lincoln University, Lincoln University, Pa. (Horace Mann Bond, President), August 15, 1950, mimeographed letter seeking to develop a Lincoln collection; pamphlet, Lincoln University and the Medical Sciences.
- Lindstrom, Ralph G. (Lincoln Fellowship of Southern California), June 11, 1941, praising Pratt's two volumes in the series, *Lincoln Day by Day*; and November 8, 1949 (copy of letter to Marion Bonzi) regarding the Lincoln campaign scrapbook for 1858.
- Little, Brown & Company (Herbert F. Jenkins), November 6, December 4, 1939, regarding Pratt's review of Agnes Rogers's book, *Abraham Lincoln: A Biography in Pictures...* (1939).
- Lorant, Stefan, Scarsdale, New York, and Lenox, Massachusetts, letters, telegrams, postcards, November 24, December 5, 1941; February 22, March 9, 1942; January 18, December 27, 1951; January 29, June 22, June 30, July 25, July 28, August 12, November 18, 1952; January 1, 1955, mainly regarding Lorant's *Lincoln: His Life in Photographs* (1941) and *Lincoln, A Picture Story of His Life* (1952), books that Lorant sent to the printers before taking Pratt's corrections into account. Lorant's letter of November 18, 1952 apparently refers to the newly-discovered "coffin picture" of Lincoln and the "misunderstanding" between Lorant and Pratt over its publication in *Life*. See also Lorant's volumes as cataloged, including a dummy copy, with annotations and notes by Pratt.
- Lowden, Frank O., Oregon, Illinois, to Thomas Rinaker, Carlinville, Illinois, April 26, 1925, declining an invitation.
- Luedke, Hermann, Wurzburg, Germany, to Mrs. Knudsen (Garden Club of Illinois, Springfield), May 29, 1940, referring to his play, *Abraham Lincoln* (translated 1936).
- Luthin, Reinhold, March 6, 1950, asking for information on the almanac trial.
- McClelland, Stewart W. (Lincoln Memorial University), July 3, 1941, congratulating Pratt on finishing the *Day by Day* series.
- McPharlin, Paul, Birmingham, Michigan, June 19, 1942, asking if Lincoln ever saw a puppet show.
- Mearns, David C., October 12, 1949, indicating his delight on Pratt's "return to Mr. Lincoln."

- Megan, Charles P., Chicago, January 6, 1939, enclosing a copy of his article, "Reflections on Lord Macmillan's Visit to Chicago," Chicago Bar Association Record (November 1938).
- Meserve, Frederick H., January 11, 1951; May 21, July 15, 1953, on the publications of his Lincoln photographs and Lincoln's Ellsworth's Letter.
- Missouri Historical Society (Charles van Ravenswaay), November 28, 1950, regarding Lincoln items in the *Missouri Republican*, and a file of *The Curiosity Hunter* (Belvidere [Rockford?], Illinois 1876-77).
- Mitgang, Herbert, November 14, 1955, thanking Pratt for photostats contributing to Mitgang, editor, *Lincoln as They Saw Him* (1956).
- Monaghan, J. (Illinois State Historical Library), September 13, 1950, reference to Pratt's marriage.
- Morehouse, Frances, Shafer, Minnesota, August 20, 1938, regarding the papers of Jesse Fell and David Davis.
- Nathan, Adele Gutman, New York, June 15, 1955, reply to Pratt's corrections of her *When Lincoln Went to Gettysburg* (1955). Also Pratt to the publisher, June 9; publisher's reply, June 13; Pratt's acknowledgment, June 22; and Pratt to the author, June 22, 1955.
- National Archives and Records Service (Jane F. Smith), April 30, 1952, regarding the identity of the recipient of a note from Tad Lincoln.
- Nevins, Allan, January 5, 1953, somewhat regretting the publication of *The Statesmanship of the Civil War* (1953), his Page-Barbour lectures at the University of Virginia.
- New York Times Book Review, October 7, 9, 1949, asking Pratt to review Kenneth P. Williams, *Lincoln Finds a General*, Vol. 3.
- Newman, Ralph, to Marion Bonzi Pratt, August 17, 1959; undated
- Nicolay, Helen, June 11, 1941; January 9, 1943; August 20, 1953; January 12, 1954, thanking Pratt for *Lincoln, 1809-1839*, and *Abraham Lincoln Chronology*; also a copy of Pratt to Helen Nicolay, June 12, 1952, on letters of Willie and Tad Lincoln.
- Oakleaf, Josephus Leroy (son of Joseph Benjamin Oakleaf), carbon typescript of his remarks at the program to mark the acquisition of the Oakleaf collection of Lincolniana by Indiana University [February 13, 1943]; Robert E. Miller (director of libraries, Indiana University), June 6, June 15, 1945, on additions to the collection.
- Packard, R. D., Cleveland Heights, Ohio, January 28, 1950, on being delighted that Pratt is "ack in the Lincoln field."

- Thomas, Benjamin P.: To Arthur T. (Lexington, Kentucky): To Charles Kirkendall (Peoria, Illinois), September 29, 1942, regarding errors in his unpublished manuscript "Whiskey in Illinois," particularly one taken from Emanuel Hertz, *Lincoln Talks* (1939); to Pratt, February 2, July 12, 1955, regarding pictures for Townsend's books.

3. Books

Most of these books contain annotations by Pratt. Some contain original manuscripts that Pratt tipped in, and a few contain inscriptions or other writings by the author.

Of particular interest in this collection of Pratt's books is his copy of Carl Sandburg's *Abraham Lincoln: The Prairie Years*. Pratt affixed 89 original manuscripts, mostly court papers, into those two volumes. If a particular person was mentioned both in one of Pratt's manuscripts and in Sandburg's text, Pratt would paste the item as near as possible to the point of the text where that person is mentioned. Appendix A contains the list of items Pratt tipped into his copy.

Appendix B contains the list of items Pratt added to his copies of *Abraham Lincoln 1809-1858* and *New Letters and Papers of Lincoln*.

Appendix A

This is a brief inventory of manuscripts that Harry Pratt pasted into Carl Sandburg's two-volume biography *Abraham Lincoln, The Prairie Years*. The volumes came to the University of Illinois from the Marion D. Pratt estate and were apparently Mr. Pratt's personal copies. Pratt pasted manuscripts bearing the handwriting of various Lincoln contemporaries, usually adjacent to a section of text where that respective individual was mentioned. In a few instances Pratt obtained manuscripts which highlighted or emphasized the text and pasted that item adjacent to that section. The origin of the manuscripts are unknown, although several appear to

have been from Sangamon and Macoupin County (Illinois) circuit court case files and probate estate files. The volumes have the following University of Illinois call number: 973.7L63 Bsa5ap cop. 13 (vol. 1 and 2). This inventory was drafted on October 1 and 2, 1998.

- Opposite p. 34: Legal Instrument, Certificate of Protection, APPDS, October 2, 1835, to Seaman William Richards written and signed by A.B. Fannin(?) Collector of the District of Savannah. This document served as Richard's proof of citizenship. This document is pasted in a section of text which discusses indentured servitude (pages 34-35).
- Opposite p. 84: Currency, One Dollar-Indiana Script (from New Harmony), PPDS, 1862, signed by George T. Beatty (?) and J.E. Ricketts (?). This item is pasted in a section of text which mentions New Harmony, Indiana (pages 4-85).
- Opposite p. 92: Letter, ALS, September 10, 1835, from Heberton, Heiskell, & Hoskins of Philadelphia to Anderson, Bell & Co. of Louisville. A letter of introduction for Benjamin Godfrey, esquire of Lower Alton, Illinois. There is no obvious relation to the surrounding text.
- Opposite p. 108: Legal Instrument, Third of Exchange (promissory note?), APPDS, October 11, 1847, from Alexander & John Dennistoun & Co. of New Orleans and Liverpool to Timothy Keffe. This item is pasted in a section of text which mentions New Orleans (page 108).
- Opposite p. 120: Letter, ALS, May 10, 1819, from M. Holbrook of Charleston NC to Clarke Holbrook of (?) Massachusetts. Letter mentions slave runaways and punishment, and this matches text about slavery on page 121.
- Opposite p. 138: Currency, Five Dollars, APPDS, December 18, 1838, from Hernando Railroad & Banking Co. to F. Labanne. This item seems to match text on page 138, which mentions "Wildcat money."
- Opposite p. 142: Legal Instrument, Appeal Bond, PPDS, February 26, 1840, Sangamon County Circuit Court (hereafter SANCC). Written by Noah W. Matheny, deputy circuit clerk, signed by David Batterton and his surety John Wiseman (by his mark). This bond was taken to bring an appeal from the Justice of the Peace to SANCC in Webster & Hickox v. Batterton on a \$50.83 judgment. This document follows the text which mentions Wiseman on page 143.
- Opposite p. 146: Legal Instrument, Subpoena, ADS, May 15, 1831, SANCC. Written by Charles R. Matheny clerk of circuit court for Vincent A. Bogue to appear as witness in People v. William Watson. This document follows the text which mentions Bogue on pages 146-147.
- Opposite p. 158: Letter, ALS, April 24, 1886, from Mary Stuart to Judge David and Sarah Davis (Sarah had already passed away by this date?). Appears to be a sympathy letter. The text on page 159 mentions John T. Stuart.

Appendix B

The following lists are the contents of various original documents collected by Harry Pratt and subsequently glued into books from his personal library given to the University of Illinois. According to Ralph Newman, Pratt had acquired this bad habit early in life. The documents are probably not very valuable save for the Seward signatures and those of Lincoln's associates that are more prominent. Pratt had a method to his madness, affixing the document to the page where a reference is made to one or more of the names found in it. He would highlight the reference on the printed page by underlining it in pencil and then paste the document between the pages. Most documents tend to be legal in nature, such as petitions, summons, cancelled checks, receipts, and bonds.
