## Randolph and St. Clair Counties, Illinois. Papers, 1814-1819

- 1. Circa 1814-1818. Randolph County appeal bond, a blank printed form.
- 2. July 12, 1815. Arrest of James Gilbreath to appear before the Randolph County Court, Kaskaskia, to answer Wharton Remsdale who is seeking to recover a debt of \$80. Signed by William C. Greenup, clerk of the court.
- 3. August 2, 1815. Summons of James Gill to appear before the Randolph County Circuit Court in the case of *James McLean v. Benjamin Walker*, signed by William C. Greenup, clerk of the court.
- 4. September 15, 1815. Papers, signed in Kaskaskia by Matthew Duncan and others, in the case of *Ephraim Bilderback v. James Gilbreath* for a debt in which "a negroe man named Harry Shown," an "Indentured servant," is attached.
- 5. November 1, 1817. Summons of Jessie W. Cooper, Alexander Lamson, and James McRoberts to appear as witnesses in the case of *George Ramey v. William Biggs et al* [other defendants include Wm. Biggs, Jr., George Biggs, Jacob Lunieford, Wm. Lunieford, Robt. Hayes, and Wm. Read]. Signed by John Hay, clerk of the St. Clair County Court, Belleville.
- 6. September 7, 1819. Promissory note of John R. Harris and William C. Greenup to Samuel Whiteside, Levi Compton, Thomas Cox, William Alexander, and Guy W. Smith, \$202, for a lot in the town of Vandalia (the new state capital).
