This series contains research materials and unpublished research drafts of Professor Blair Kling and in particular his research on the Tata Iron & Steel Company in Jamshedpur, India, and early American and British influences on Indian entrepreneurship and heavy industry. Also included are Kling's interviews and transcripts in Jamshedpur with representatives of social movements, industry, unions, tribes, schools, etc. Of note is the grey literature, internal reports, and pamphlets by the Tata Steel Company; grey literature by India's labor movement, the Communist Party, and small publications on topics such as rural development, nationalism, and geology. This series also includes 8 microfilm rolls of the Motif newspaper (1973-1992), Tata Steel Company records, copies of the Frederick Charles Temple Papers, newspaper reports of labor strikes in Jamshedpur.
