<u>Box 1</u>:

Personal scrapbooks. Contain mainly newspaper clippings, although meeting programs and job appointment letters were also occasionally included.

February 17 1874-Nov. 6 1880. Clippings mainly from the *Albany Express* and *Albany Evening Courier*. Also includes a few letters. Topics covered include Draper's involvement in the American Order of Independent Grangers, the Independent Order of Good Templars, the Republican Party, Draper's election to the Albany Board of Public Instruction, Draper's activities as President of the Albany General Republican Committee, and his nomination and election to the New York State Assembly.

January 11 1880-January 26 1882. Clippings mainly from Albany newspapers, although some also from other New York state newspapers. Topics include Republican caucuses and meetings, the 1881 visit of former president Grant to Albany, a legal challenge lodged against Draper's election to the New York General Assembly, Draper's subsequent activities as an assemblyman (particularly his support for Roscoe Conkling in the U.S. Senate election), Grant Club meetings, and Draper's 1881 defeat in his reelection bid (the result of a factional dispute over his support of Conkling).

Box 2:

January 16 1882-August 14 1883. Clippings mainly from Albany and other New York state newspapers, covering activities of the Albany Grant Club, Draper's involvement in overturning the fraudulent 1882 Albany mayoral election, and his failed candidacy for the 1882 Albany second district assembly seat.

September 1 1883-October 1889. Clippings from Albany and other New York newspapers. Topics covered include Draper's 1884 attempt to take control of the Albany Republican Committee and the state Republican machine from his political mentor John F. Smyth; Draper's appointment as a Commissioner for the Alabama Claims by President Chester Arthur, and as New York State Superintendent of Public Instruction; and the death of Roscoe Conkling.

Box 3:

January 5 1887-February 13 1888. Clippings from Albany and other New York papers, covering educational topics, including Draper's activities, reports, and press releases as State Superintendent of Public Instruction.

January 23 1889-February 22 1898. Clippings from New York, Ohio, and Illinois newspapers. Topics include Draper's appointments as Cleveland Superintendent of Public Schools and President of the University of Illinois, and his activities in each of these offices. A group of loose scrapbook pages marked "Personal--Andrew S. Draper Scrapbook January 1889 to May 1889" contains clippings related to Draper's activities as New York State Superintendent of Public Instruction.

Box 4:

February 16 1898-June 7 1904. Clippings from New York and Illinois newspapers, covering Draper's rejection of a 1898 offer to become Superintendent of New York City Public Schools, the publication of *The Rescue of Cuba*, his 1902 carriage accident and subsequent leg amputation, and his selection as New York State Commissioner of Education.

November 14 1904-December 16 1907. Clippings from New York newspapers, indexed topically and covering Draper's activities and policies as New York State Commissioner of Education. Issues treated include Draper's ideas for collegiate football reform, his commencement and other speeches, and his decision to ban the wearing of religious garb by public school teachers.

<u>Box 5</u>:

December 16 1907-January 5 1912. Indexed clippings, mainly concerning Draper's activities and speeches as New York State Commissioner of Education, especially his advocacy of agricultural and trade education in public schools.

January 12 1912-July 9 1913. Clippings, mainly regarding Draper's activities as State Commissioner of Education, including his support of anti-trust legislation. Also covers Draper's death, funeral, and obituaries. [Note: This item, which was first acquired on Jan 13, 1964, was transferred from record series 2/4/5 at the time of processing. It was not included in the scrapbooks purchased from Associated Appraisers.

Obituaries and memorials scrapbook, marked "Dr. Edwin Draper," compiled by of for Draper's son Dr. Edwin Draper, April 28-May 22 1913. [Note: This item, which was first acquired on Jan 13, 1964, was transferred from record series 2/4/5 at the time of processing. It was not included in the items purchased from Associated Appraisers.

Obituaries and memorials scrapbook, marked "Mrs. Brown's Book" and compiled by or for Draper's daughter Charlotte Draper Brown, April 28-May 22 1913.

Box 7:

Saturday Evening Post Magazine, Feb. 3, 1917. This item was included with the purchase of materials from Associated Appraisers, although no direct connection to Draper could be established at the time of processing.

Bound, typed transcripts of correspondence, in 3 volumes. The letters in these volumes were bound and transcribed by an unidentified person.

Andrew S. Draper to his cousin Alden Chester, 1859-72; and Alden Chester to Andrew S. Draper, 1861-72. Topics covered in these 2 volumes

include Draper's schooling, his family life and relations with relatives and friends, his involvement in the temperance movement, particularly the Independent Order of Good Templars, his attendance at President Lincoln's funeral procession in Albany, his business dealings as a lumber salesman for C. D. Whitney, his political speeches and activities, his decision to become a lawyer and form a partnership with Alden Chester, and their subsequent dealings in this practice.

Andrew S. Draper to his cousin Alden Chester, 1884-86, 1892-1904, and one letter to his mother, June Sloan Draper, 1894, and one letter from John M. Chase to Andrew Draper, July 30, 1892. Topics covered include the state of the Draper/Chester law practice during Draper's tenure as Commissioner of the Alabama Claims, his activities as a Commissioner, his involvement in Albany and Washington politics, his canvassing for appointment as New York State Superintendent of Public Instruction, his personal financial dealings and family matters, his decision to accept the University of Illinois presidency, and his subsequent activities in that office.

Letterpress copybook, "Personal September 6 1901-March 23 1903." This volume overlaps files held in 2/4/5 and includes some correspondence to professional colleagues at other institutions, members of the University of Illinois Board of Trustees, or friends in New York. Some letters regard Draper's routine financial and other private affairs. Some are faded and difficult to read.
