Biography history of the subject of the manuscripts

The present collection of manuscripts consists of types, hand-written and mimeographed writings, some of which apparently form complete works, others which contain chapter and/or section headings without reference to a larger whole of which they presumably form a part, and still others unidentified by chapter, heading or general title. Attempts to identify the material with any published works contained in the University of Illinois Library have been unsuccessful, and it is presumed that the majority represents unpublished work. Manuscripts which seem to be complete and self-contained in the present collection are:

- 1) The Psychology of Football, written in collaboration with Robert C. Zuppke (1935),
- 2) The Human Nature Bases of Conflict in Education (ca. 1955), and

3) Two experimental reports concerning the Chicago National League Baseball Club (1938-39).

Most material contains annotations and corrections, presumably by Professor Griffith. There appears to be a certain amount of duplication, but because of the annotations, each draft appear to be of value. With the exception of earlier writings on sports and football, the material appears to be rather general in nature, dealing with education and psychology and with larger subject of political, social and philosophical interest.

Most of the material seems to be of value intrinsically and also for its significance for studying the author's development.
