## Box 8:

Bill of Rights - Part II - The relationship between state and federal Bill of Rights. Protest under the Illinois State Constitution from Nauvoo to Cicero. Includes: Kerner on discrimination, riot/national guard, Sullivan, Garvey, right to protest, Nauvoo: Mormons with Joseph Smith led army against anti-Mormon newspaper "The Nauvoo Expositor".

#### Box 9:

Judicial Department - Development of the Illinois Judiciary: the Supreme Court, Appellate Court and Circuit court. 14th Amendment to the constitution -Judicial Amendment. Includes: Statehouses at Kaskaskia and Vandalia, Lincoln footage - Lincoln riding horse, Mt. Pulaski Courthouse, 1831 map of Illinois, Fort Dearborn. Guest is Rubin Cohn, University of Illinois Law Professor and one of the drafters of the new judicial article.

#### Box 10:

Homerule for Chicago - Constitutional Homerule in Illinois. Professor Cohn on municipal homerule in Chicago. Chicago and the Illinois Constitution. Includes: Marquette, Jean Baptists Point de Sable, John Kinsie.

## Box 11:
