 - Ray A. Billington, Fisher and Cornell University Press on revision and publication of Fisher's book on slave songs in the United States.

Fisher, Miles M., 1947-48 Rejection by the Fund Committee of Fisher's manuscript on Lott Cary, missionary to Liberia. Ford, Guy Stanton, 1942-51

- General correspondence of Ford, Executive Secretary of the American Historical Association, concerning the Fund Committee and mainly directed to Committee chairmen Sidney R. Packard and Ray A. Billington.

- History Carnegie Committee, Data
 - Appears to be data collected by Stearns for a history of Fund activities. Includes notes from annual reports and data on costs and royalties of publications. Also includes letter of Stearns to Boyd C. Shafer (1/14/55) on background and financial affairs of the Committee in relation to the need for additional funds.

Hicks, John D., 1942

Hicks and Sidney R. Packard on fund Committee affairs and transition from the chairmanship of Hicks to that of Packard.

Hoyt, Robert S., 1950

Inquiries directed to Ray A. Billington from various hopefuls with manuscripts they wanted published.

Inquiries, 1955-58

Directed to Stearns as chairman, includes replies from Stearns and some opinions on manuscripts. It is indicated in the correspondence that the funds for the Carnegie Revolving Fund ran out by 1956. The name was changed to the American Historical Association Revolving Fund Committee with Stearns still chairman, but sufficient funds for publication were still not available by 1958.

Packard, Sidney S., 1945

Packard and Ray A. Billington on Billington's assemption of Fund Committee chairmanship. Also included in the correspondence are references to personal and family matters of the two men.

Shafer, Boyd C., 1953-58

- Largely correspondence of Shafer (Executive Secretary of the AHA) and Stearns on administrative matters especially the unsuccessful attempts to replenish the funds of the committee. Also included is Stearns' request (10/30/58) to be replaced as chairmen.
