Faculty Participation in the Formulation of Policy Conference (January-March 1959)

Conference called by President David D. Henry on March 13-15, 1959 to study effective ways faculty could participate in formation of university policy. Includes a "Preliminary Outline" of the problem drawn up before the Conference and "Athletic Policies, The Intellectual Climate and Faculty Participation" and Faculty Participation in the Making of Policies Governing Student Affairs."

Illinois Citizenship Clearing House Committee (November 15, 1955-April 3, 1956) State-wide executive committee set up by President David D. Henry for 1956 on a one year experimental basis as an affiliate of Citizenship's Clearing House (Headquarter New York University) designed to encourage college student participation in policies and composed of faculty from Illinois universities plus politicians and civic leaders. Includes reports and letters relating to the setting up of the Committee as well as to committee work itself, specifically, for example, "Planning Notes for Affiliation," litters from the Illini Young Republicans, memos and letters to and from Provost Henning Larsen, and minutes of the February 27, 1956 Committee meeting with a list of people to be invited to the state-wide conference March 28-29, 1956.

University of Missouri, Chancellors Advisory Committee on CAPA Reorganization (September-October 1974)

Committee of three formed to study reorganization of the College of Administration and Public Affairs, specifically whether the Department of Accountancy should be made into a separate school. Folder 1 contains covering letters and documents sent to Peltason prior to consultation of October 27-29, 1974 which fall into two categories:

1) U of Mo. reports on the situation and the problem (1971-74) and 2) outside scholarly studies which pertain to the local problem. It includes "Report to the Chancellor on 1972 CAPA Reorganization," Ernest A. Englebert's "Guidelines and Standards for Public Affairs/Public Administration," and originals of letters to Peltason from H.W. Schooling, Chancellor, U of Missouri, setting up the consultation, August 30-October 10.

Folder 2-University of Missouri, Chancellor's Advisory Committee on CAPA Reorganization (October 30, 1974-January 2, 1975)

Mainly papers on the result of the consultation, copies of all correspondence to and from Peltason relating to the conference, plus Peltason's travel vouchers and plans. Includes Chancellor Schooling's final recommendations (December 11), the committee's recommendation to Schooling (November 12), and letters to and from Dean William Baughn, University of Colorado, and Vice President George Pinnell, Indiana University, the other committee members, plus a University of Missouri report sent prior to the consultation Merl Baker's Multicampus and Consolidated

<u>University Systems</u>, 1974.

G.A.O. - Advisory Panel on Service Academies (1973-1976)

Panel formed by the G.A.O. to study the academic programs of the five service academies (Military Academy, Naval Academy, the Air Force Academy, Coast Guard Academy, and Merchant Marine Academy), their case effectiveness, and specifically, the cause of the academies' high attrition rates with meetings held November 1973, April 1974, September 1974, and November 1974. Folder 1 consists largely of covering letters and Peltason's answers plus documents sent to Peltason analyzing and describing the situation of the academies sent to Peltason by David P. Sorands, Deputy Director, Federal Personnel and Compensation Division, G. A. O. It includes discussion papers about curricula and faculty, studies of attrition rates and costs, a profile questionnaire given to academy students, a 1970 Report to the Congress of the U.S. on Financial Operations of the Service Academies, and minutes of panel meetings.

- G.A.O. Advisory Panel on Service Academies, Air Force Information Kit (1974). Documents to prepare participants for the April 3-4, 1974 meeting at the Air Force Academy. Includes faculty profiles, 1969 accreditation report of the North Central Association of Colleges and Secondary Schools on the Air Force Academy, and a curriculum history, all in random order.
- G.A.O. Advisory Panel on Service Academies (1973-1976)
 - Consists largely of letters to and from Peltason papers relating to travel and compensation for Peltason plus the final report. It includes letters to and from H.L. Krieger, Director, Federal Personnel and Compensation Division, G.A.O., Elmer B. Staats, Controller and Thomas D. Morris, Ass't Controller General, Plus the March 1976 final report, Phase 1, Student Attrition at the Five Federal Service Academies along with reactions to the impending report by General Frederick A. Smith, Jr., Dean, U.S. Military Academy.
