- Formerly operated under the names Darley Associates Limited, and Essential Oil & Spice Ltd. Mr. G. L. D. Thomson was the managing director, in St. Margaret's Bay, and was in charge of plantation operations during most of the company's life.
- Mr. Julius C. Walenta managed most of the company's affairs from Kingston, and most of the correspondence in these files involves him. For more information, see the folder labeled General "C", and also those labeled Management.
- The company was partly owned by Fritzsche Brothers of New York, was supported by them, and existed primarily for supplying them with essential oils and spices.
- Most of these documents cover the period 1957-1969, and include correspondence, business operations files, journals, samples of chick stub books and routine financial documents and samples of labor records.
