Balfour, 1954-58, October letters concerning controversy over publicizing the National Student Association in which Turner urges on IRAC a policy of cautious co-operation, letter of September 24, 1954 from Balfour to Frank J. Buck discussing practices of pirates of fraternity names and insignia like Brochon, Victoria Products, Runyan of California, and the L & L Company of Philadelphia; correspondence concerning political fight within the National Interfraternity Conference between friends and foes of IRAC, November 1954; results of a survey of alumni of Newark College of Engineering concerning the merits of fraternities in general; letters of February 24 and March 10, 1955 in which Turner and Balfour endorse the idea of co-operating with a proposed study of the place of fraternities and sororities in the American college by the American Council on Education; letter of March 10, 1955 in which Turner declines Balfour's suggestion to serve as chairman of NCCFS because of increased duties resulting form impending change of presidents at University of Illinois and another of March 17 revealing Turner's suspicions of the impending conference at the Massachusetts Institute of Technology on "Selectivity and Discrimination in American Universities;" draft of Balfour letter to fraternity officers expressing his fears of the National Student Association; Turner's letter of September 9 discussing controversy within Sigma Alpha Epsilon convention over the issue of selectivity and discrimination (a split between Northern and Southern chapters) and September 22 discussing the NAACP's pressure on the University of Illinois to help end racial discrimination in Champaign-Urbana, and the powers of the Board of Panhellenic Affairs; copies of letters from readers critical of the IRAC Bulletin; Turner's letter of February 8, 1957 discussing impending crisis at University of Michigan concerning anti-discrimination action against Sigma Kappa by a student government with authority delegated to it by the Regents and noting the implications for other campuses, especially Illinois: "The NAACP through one of the ministers in the campus Methodist church is certainly putting the heat on us and at the present time is attempting to get a student referendum on the whole question. The pattern is exactly the same as the being used all around the country. Just how seemingly intelligent people can fall for it is more than I can understand, but they seem to do it;" Turner's confidential letter of May 23, 1957 discussing "finagling" involved in initiating President and Mrs. David D. Henry into Phi Kappa Psi and Kappa Alpha Theta respectively; letters of May 1957 discussing fraternities' and sororities' success against the passage of the anti-discriminatory California Assembly Bill #758; correspondence in June 1957 critical of President McDonald of Bowling Green linking him with the NAACP and blaming him for a riot involving fraternity students at his school; carbon copy of letter from Balfour to Frank H. Meyers on August 26, 1957 discussing Notre Dame's success in a suit against the John Roberts Company 41/1/41 7

to protect its name, insignia, and ring design; Wilson B. Heller's "Comparison and Rush Guides for College Fraternities and Sororities Only for Year 1956," Conference's penchant for operating "in a vacuum" apart from college presidents, deans, and undergraduates; Balfour's letter of November 11, 1957 to Stewart D. Daniels discussing merits of merging the NIC Central Office and the IRAC offices as well as discontinuing the NIC News; correspondence between Turner and Balfour in January 1958 accusing the NIC Jewish fraternity of supporting NIC publicly on the selectivity and discrimination issue while privately "following the advice and actually the instructions of the American Jewish Committee" to the contrary; Turner's letter of February 7, 1958 reporting on the postponement of the deadline at Columbia University for fraternities there to eliminate their discrimination clauses; correspondence between Turner and Balfour in February agreeing that they should get the Association of College Honor Societies in IRAC "if there is any way to do it in a dignified fashion;" correspondence with Burns B. Crookston in June 1958 concerning William P. Butler's study "Factors Associated with Scholastic Achievement in High and Low Achieving Fraternities;" Correspondence with Margaret O'Leary, 1954-58 (2 folders) including her proposals for articles and business arrangements concerning the Bulletin
